Tom Conroy addressed Secretary Gates' DOD Efficiency Initiative and its subset, Dr Ashton Carter's, USD A,T&L, Better Buying Power Initiative.

"Beginning in May of last year at his speech at the Eisenhower Library, Secretary Gates launched a multi-pronged efficiency initiative to ensure DOD is managing the budget in a manner that is respectful of the taxpayer at a time of economic and fiscal distress. As one of those prongs, he tasked Dr. Ashton Carter, USD A,T&L, as the Acquisition Executive to devise a plan for the \$400 billion out of the approximately \$700 billion base-plus-wartime budget that is contracted out, resulting in the September 14 Better Buying Power initiative."

ASK MAC!

Dear Mac,

My boss wants to buy command coins to give out to visitors as a memento of their visit and to give to employees to build loyalty and improve morale. I want to be sure it is legal to use appropriated funds for this purpose, but everyone I talk to has a different opinion. He's pressuring me to make it happen and I need to provide him with an answer soon.

Please HELP!!! Lola

Lola,

That's a great question and one that is asked frequently. So let's discuss when you can and can't use appropriated funds to purchase coins.

10 U.S.C. 1125 authorizes DoD to award medals, trophies, badges and similar devices for excellence in accomplishments and outstanding performance. Command coins would fall under this statute. It is proper to purchase command coins as long as they are used as awards for outstanding accomplishments. Coins purchased with appropriated funds may only be given as awards.

Coins given as mementos, tokens of appreciation, or to build loyalty to the command and improve employee morale are not awards. Coins used for these purposes should be purchased with private funds. Based on what your boss wants to use them for, tell him to pull out his credit card because he's going to have to pay for them himself.

“Life is what happens to you while you are busy making other plans.” John Lennon

I was busy making other plans. Working full time as a Financial Analyst at MSC, having recently moved to a new home, busy remodeling the old house to turn it to a rental, the guardianship of a young child and Chapter Rep for ASMC San Diego Chapter... the to do list went on. That was until I was diagnosed with ALL, Acute Lymphocytic Leukemia. My world came to a sudden halt as I contemplated exactly what that meant.

The prognosis: about 30-40% of adults with this diagnosis are successfully treated. The treatment: 12 weeks of ‘induction’ chemotherapy followed by intense chemotherapy and a stem cell transplant from a matched donor followed by about a year of recuperation. All this required six periods of hospitalization. The longest stretch was about 2 months to treat an infection I developed as a result of the induction chemotherapy. Much of this time I was in intensive care in an induced coma.

The best luck of all was that my brother was a match for me as a donor. He came down here from San Francisco to donate his healthy stem cells to replace my diseased ones. I will always be grateful to him for that. Luckily I had quite a bit of sick leave ‘banked’ if ever I needed it for an emergency. My command was very supportive in allowing me to telecommute from the hospital and from home as I was physically able to do so. I was in medical isolation at UCSD after the transplant but was still able to RAS into NMCI resources, email, our department’s share drives, our financial system and Defense Travel System. After I left the hospital for the last time, my command allowed me to work from home for about 4 hours a day as I was on immune suppressants and receiving treatment in my home or at the Moore’s Cancer Center almost every day. Many of my friends and co-workers came through for me in donating leave which allowed me to take the time I needed to recover.

One thing I learned is not to be afraid to ask for help. Everyone was not only happy to help but glad that they could do something. I needed a support team to get through it. My family and friends were there for me. Co-workers and management were extremely supportive. I reached out to the American Cancer Society for their expertise and services. The Rock church provided drivers for my frequent trips to the clinic when my doctor would not allow me to drive.

The latest news is that almost one year post transplant, I am able to work four days per week and am steadily improving. I look forward to the day when I am back to work full time and have the stamina to help others.
